

**FOR IMMEDIATE RELEASE
GOVERNOR ANNOUNCES GRANT AWARDS**

Charleston – Governor Joe Manchin III announced today that he has awarded \$5,261,504 in West Virginia General Revenue and Community Corrections funds for twenty-two (22) community correction projects. These funds will be used to assist local communities in the establishment and continued operation of community corrections programs.

The West Virginia Community Corrections Act Program is intended to provide a means for communities to develop, establish and maintain community based corrections programs to provide the judicial system with sentencing alternatives for those offenders who may require less than institutional custody. These funds will be administered by the West Virginia Division of Criminal Justice Services. Funds were awarded to the following:
